



## 2018 National Landcare Conference

### *Goulburn Broken CMA Sponsorship Expression of Interest Form*

The Goulburn Broken CMA is pleased to offer sponsorship of up to \$500 (Including GST) for community members to attend the 2018 National Landcare Conference and National Landcare Awards Gala Dinner.

Sponsorship is available to community members from the Goulburn Broken Catchment who can demonstrate their dedicated involvement in natural resource management and/or sustainable agriculture activities in the region over the past two years. Furthermore, you and/or your group/network must submit an abstract to share your story at the conference (guidelines on abstract submissions are available on the conference website and are due by 27 June 2018) – if your abstract is not accepted you will still be eligible for sponsorship.

Sponsorship will cover the conference registration fees, a ticket to the National Landcare Awards Gala Dinner and \$115 towards your travel costs. Please note, successful applicants will be required to organise and pay for their own accommodation and travel to Brisbane to attend the conference. Furthermore, sponsorship doesn't include field trip costs. If you have already registered to attend the conference you are still eligible to apply for sponsorship.

Each attendee receiving sponsorship will be required to submit a short written report to the Goulburn Broken CMA within four weeks of attendance detailing their experience at the conference, including lessons learnt, outcomes and how they will share this knowledge with their local community.

Sponsorship funds are limited and applicants will be assessed on the information provided in the following EOI form. There are no restrictions on the number of applicants from any one group/network, however as we are keen to support as many groups/networks as possible this may be taken into account during assessment.
