



Freedom of Information Request

Request for access to documents under the *Freedom of Information Act 1982 (Vic)*

Under the Freedom of Information Act 1982 (Vic) (FOI Act), every person has the right to request access to documents held by Victorian public sector agencies and Ministers. This right of access is subject to exceptions and exemptions necessary to protect essential public and private interests.

Making a valid request Under Section 17 of the FOI Act, a request must meet three requirements to be valid:

1. The request must be in writing.
2. Sufficient information must be provided about the documents that are being requesting so the agency or Minister the request is sent to can identify and locate all relevant documents; and
3. The application fee must be paid. If payment of the application fee could cause hardship, a request can be made to GB CMA or Minister to waive the fee in full or in part.

Request Submission

Once an application has been received, Goulburn Broken CMA (GB CMA) will assess it to ensure it meets the requirements outlined in Section 17 of the FOI Act. If it is determined the request is not valid, a notification will be sent within 21 days from the date the submission was received, provide guidance in making a request valid.

If the request is valid, processing will begin.

Timeframes

Goulburn Broken CMA has 30 days from the date of receiving a valid request to provide a decision. However, time can be extended by up to 15 days if additional time is required to consult with third

parties whose information may be contained in the requested document(s). Time may also extend this time by up to 30 days with your agreement if required. Goulburn Broken CMA will provide notification if time frames are required to be extended.

Charges

In addition to the application fee, certain charges for searching and providing access to the documents may be payable.

Charges are calculated in accordance with the Freedom of Information (Access Charges) Regulations 2014 (Vic). If search and/or access charges are expected to exceed \$50, GB CMA will provide an estimate of the charges and request a deposit be paid before the request is processed. At this time, GB CMA will seek confirmation of whether the request is to proceed or be amended to reduce anticipated charges.

How your personal information may be handled

By submitting this form, personal information is being handled by the GB CMA. Personal information will be used for the purpose of processing FOI requests only. Consultation may be required with third parties in considering whether an exemption under Sections 29, 31, 31A, 33, 34 or 35 of the FOI Act applies. This may involve disclosing details such as name/s, the terms of the request, and documents falling within the scope of the request that concern the relevant third parties. If necessary, GB CMA may transfer the request under Section 18 of the FOI Act to another agency or Minister who is better placed to assist with the request. Notification of third party of another agency involvement will be made as part of the process. Please contact GB CMA directly and discuss if you have any concerns about how the organisation may handle your personal information.
