### Site description

BGGW is associated with the hill-tops to the north of the inner access track. Multi aged White Box trees with good regeneration and hollows. Ground cover appears dominated by native grasses. Abundant deadfall. Site grades into Open Forest.

#### **Threats**

- 1. Weeds and exotic grasses.
- 2. Rabbits

### **Management Options**

- 1. Area is incorporated into the Reserve Management Plan and zoned reference area.
- 2. Reserve is proposed for conservation covenant.
- 3. Weed and rabbit control.
- 4. Establish trial sites for seasonal control of weeds and exotic grasses using strategic burning/herbicide. Monitor results.
