### Site description

Multi aged White Box with moderate regeneration. Blakley's Red Gum and Yellow Box also present. Ground cover dominated by native grasses. Fragmented connectivity to other degraded roadside.

### Threats

1. Exotic Grasses.
2. Isolated from any significant core areas.
3. Depletion of deadfall.

### Management Options

1. Retention of deadfall to provide habitat.
2. Establish vegetation corridors to connect to other remnant areas and larger core areas.
3. Establish trial sites for seasonal control of exotic grasses using strategic burning/slashing/herbicide/grazing. Monitor results.
4. Shire Planning Schemes (Zoning/Overlays/Roadside Management Plans) to reflect sites values.
