Site description

Multi aged White Box with moderate regeneration. Moderate ground cover of native grasses and forbs. Abundant deadfall and ground litter. Adjacent paddocks contain good patches of Kangaroo Grass. Fragmented connectivity to other degraded roadside.

Threats

- 1. Exotic Grasses.
- 2. Isolated from any significant core areas.
- 3. Minimal deadfall.

Management Options

- 1. Retention of deadfall to provide habitat.
- 2. Establish vegetation corridors to connect to other remnant areas and larger core areas.
- 3. Establish trial sites for seasonal control of exotic grasses using strategic burning/herbicide/grazing. Monitor results.
- 4. Shire Planning Schemes (Zoning/Overlays/Roadside Management Plans) to reflect sites values.
