Site description


Southern end has 14 significant old White box trees with hollows. Abundant regeneration. River Red Gum, Grey and Yellow Box and wattles also present. Scattered patches of native grasses.

Threats

1. Weeds and exotic grasses.
2. Removal of deadfall.
3. Illegal fire sites.
4. Vehicle access.

Management Options

1. Erect signage to promote sites values and highlight constraints.
2. Strategic fencing to reduce public impacts e.g. fire pits, wood collection, vehicle access.
3. Establish trial sites for seasonal control of weeds and exotic grasses using strategic burning/slashing/herbicide. Monitor results.
4. Shire Planning Schemes (Zoning/Overlays/Roadside Management Plans) to reflect sites values.
