## **Threatening Processes**

- 1. New landholder and potential change of landuse.
- 2. Timber collection
- 3. Exotic grasses including Phalaris.

### Management

- 1. Survey flora present in Spring.
- 2. Suggest current landholder markets property for conservation values foremost.
- 3. Control exotic grasses and weeds
- 4. Trial burning/grazing disturbance regime
- 5. Revegetate with Buloke (recruitment inadequate)
- 6. Revegetate surrounding farmland to enlarge available habitat and buffer reserve from edge affects.
