#### Site description

Northern Plains Grassland vegetation near Naringaningalook and Numurkah. Gilgai areas and some treed areas are features of the property.

#### Significant flora or fauna

Yellow-tongue Daisy *Brachyscome chrysoglossa* (v)  
*Mueller Daisy* *Brachyscome muelleroides* (Ve)  
 Silky Swainson-pea *Swainsona sericea* (v)  
 Rye Beetle-grass *Tripogon loliiformis* (r)  
 Legless-lizard *Delma impar* (e)

#### Threatening Processes

1. Weeds and exotic grasses (African Boxthorn, Bathurst Burr, Wheel Cactus, Horehound, Paterson's Curse, Annual Rye-grass, Onion Grass and Wild Oats)
2. Edge affects (neighbouring agriculture), isolation and fragmentation

#### Management

1. Continue light grazing in late Summer and Autumn (not when wet)
2. Control weeds and exotic grasses (spot spraying/fire/grazing)
3. Trial disturbance regime (fire/grazing) and use adaptive management principles
4. Ongoing monitoring of flora (Spring)
5. Amend the Moira Planning Provisions to reflect conservation value (eg. ESO,VPO)
