#### Site description

Northern Plains Grassland on roadside reserve, this area has been disturbed through ploughing and grazing hence the weedy nature of the grassland remnant.

## Significant flora and fauna

None known

### **Threatening Processes**

- 1. Weeds and exotic grasses
- 2. Isolation from other grassland remnants
- 3. Edge affects from adjacent land (including spray drift, irrigation tailwater etc.)
- 4. Ploughing and soil disturbance for firebreaks or tree planting (has occurred at this site)

#### Management

- 1. Conduct flora surveys and monitoring in Spring
- 2. Consult with adjoining land managers re. conservation significance of the roadside remnant
- 3. Consider fencing the best bits to prevent ploughing as has occurred
- 4. Trial control grazing or burning to control weeds and restore functioning
- 5. Sign both ends of the roadside remnant with significant roadside signage
- 6. Shire to consider penalties where clearing has occurred for tree planting or at the very least rehabilitation/restoration works.
- 7. No mowing of roadside remnants
